North Hempstead OK's Sewer Hook-ups: "Miracle on Plandome Road"

The Town Board of North Hempstead voted unanimously - finally, at its April meeting - for a proposal by Supervisor Jennifer DeSena (R-Manhasset) to allocate \$3.1 million in federal American Rescue Plan Act ("ARPA") funds to connect the Manhasset business district to the long-stalled Manhasset sewer project.

DeSena had lobbied the seven-member Board on the allocation of federal monies for much-needed project.

Town Democrats had previously delayed the project by challenging the legality of using federal funds toward revamping the town sewer system. Those "legal" challenges proved to be nonsense, as the funding was approved.

Town Democrats had blocked the sewer project in March, when the Board split by a 3-3 vote.

"Our businesses, our residents, our environment, and the future of our Plandome Road Business district deserve this project," stated DeSena in March. "It's incredibly sad to see all of these things sacrificed by the majority to bolster their own political power, as they're presumably looking to dole out these federal funds to their own pet projects."

"The approval of these ARPA funds has gone on enough," long noted Mayor Barbara Donno of Plandome Manor. With the approval vote in April, the project will go forward. that \$3.1 Of

Million figure, \$1.76 Million will be allocated to connect 88 properties to the system, at a cost of approximately \$20,000 per connection. It also, includes \$1 million for the town facilities to connect to the sewer line.

In addition, \$334,000 will be used for other miscellaneous expenses related to the project.

North Hempstead received funds from ARPA Coronavirus Local Fiscal Recovery Funds for Non-Entitlement Units (NEUs) of local government in New York State. These funds were received in two installments in 2021 and 2022 totaling \$10,114,021.27.

The new system will reduce the costs to local businesses and restaurants on Plandome Road, as currently those owners' are paying as much as \$50,000 to \$70,000 annually to pump and maintain their septic tanks. A few businesses owners have paid as much as \$500,000 annually to maintain the old sewer system.

"It is 'the miracle on Plandome Road," stated Lynn King, a local resident of Manhasset.

Woman Gets Jail in \$600K Seawanhaka Yacht Club Scam

The Seawanhaka Corintian Yacht Club on Centre Island – the oldest sailing and yacht club on Long Island and the second-oldest yacht club in New York – was stung by the theft of over \$600,000 by a scheming long-term employee.

Anna Marie Restrepo, age 59, also known as "Anna Maria Saboski," of Glen Head, was sentenced on April 27th, to three to six years in state prison on grand larceny charges.

Restrepo pleaded guilty to seconddegree grand larceny in January for stealing over \$600,000 from Seawanhaka from 2010 to 2017. She waived her right to appeal the plea and sentence.

Restrepo had previously been convicted in 2009 of first-degree falsifying business records. In that case, she stole over \$100,000 while working as a fiscal manager at the Glen Cove Child Day Care. She was then sentenced to a conditional discharge and did not serve prison time.

Several months after that arrest, Restrepo was hired by Seawanhaka as a bookkeeper and was later promoted to boatyard office manager. In addition to b o o k k e e p i n g , Restrepo was entrusted with using the club's credit cards to make payments.

She also fraudulently used the credit card numbers of two employees and even opened an AmEx account in the name of another employee without consent and attached a supplementary account in her own name.

The Seawanhaka Corinthian Yacht Club was founded in September 1871 aboard the sloop Glance, which was then anchored in Oyster Bay off Centre Island. The Glance's captain, William L. Swan, was elected Seawanhaka's first Commodore. The current Commodore is Jean Pierre Blaise of Bayville and the Vice Commodore is Robert Fagiola of Lattingtown.

According to prosecutors, Restrepo made over 880 credit card disbursements using stolen fraudulent funds and engineered over 460 unauthorized Seawanhaka bank transfers into her own PayPal account. Withdrawals and transactions took place at the Seneca Niagara Casino and Hotel in Niagara Falls, the Turning Stone Resort and Casino in Verona - and even in Costa Rica.

Restrepo then falsified records and altered transactions to make them appear legitimate.

In addition to her prison term, County Court Judge Teresa Corrigan ordered Restrepo to repay \$608,886 in restitution to the Seawanhaka Corinthian Yacht Club, and \$14,449 to American Express.

"It is an acknowledgment of his dedication and service to the people and the community he loved and inspired," concluded Ferro. The driver of the SUV had swerved to avoid a collision with a truck that had run into the intersection at Northern Blvd and Glen Cove Road. The SUV ran straight into

the glass windows of the jewelry store, with only the back part of the vehicle showing to the street. Glass and debris was scattered on the sidewalk and street.

The jewelry store was only built a few years ago at the busy intersection.

Thankfully, the SUV driver suffered only minor injuries, and the truck driver was not injured.

The SUV careened through the win-

dow of the store facing onto Northern Boulevard.

According to Nassau Police, the SUV stopped only after hitting a display case inside the store. The display case was empty and the store was closed at the time of the accident.

No jewelry was damaged or missing, and no charges were filed according to Nassau Police.

New York's Disgraceful -Totally Failed - Family Courts

The murder of 7 year old Thomas Valva a child ordered by the Suffolk Family Court to be taken away from his nurturing mother and given to an abusive - and ultimately homicidal - father - is just the most recent and dramatic failing of New York's Family and Domestic Relations Courts.

This newspaper hears every week from some attorney or parent who has seen - or been victimized - by the incompetence, indifference or corruption of New York's family judicial "system."

And we have heard - and seen - it all. Courts that play favorites. Judges that laugh at and ignore the law. Judges having affairs with attorneys and Law Guardians. Kickbacks billions of dollars - into the vast "family expert" system of appointed attorneys, forensic evaluators, supervised visitation facilities, psychologists, therapists and other "friends of the Court." It is a system of human misery, greased by the money of taxpayers and litigants bankrupted trying to cover these "fees."

Too many in the matrimonial Bar - the attorneys - have become burnt-out and cynical operators of the judicial torture chambers. A typical divorce in New York can now take five (5) years - and easily cost the parties \$250,000 between them.

"I am making a great living - and destroying New York's families, one family at a time..." joked one matrimonial attorney to this newspaper.

The inertia and corruption of the system perpetuates this dysfunctionality. And it destroys people and screws-up children - who sometimes spend half of their youth "in the system."

It doesn't have to be this way. Most matrimonial cases are simple. Forced arbitration - or a good Judge who takes more than 15 minutes to review a case - could settle most cases in an afternoon.

New York's system lets lawyers drive the pace and issues - the "adversarial model" rather than the Court acting more like the Courts of France or Germany which use a Court-driven "inquisitorial model." Our current model guarantees huge delays and absurd levels of expense. The adversarial system makes sense in criminal or commercial cases. But not when helpless children and the raw emotions of divorcing parties can drive the case.

New York's matrimonial and family courts are broken. The system is a Kafkaesque nightmare. It's beyond tinkering. No Recession Break for Taxpayers

To the Editor:

As our country enters a prolonged recession lasting well into 2024, most Long Island school districts will see a substantially tax hike in their school tax bill this coming 2023-2024 beginning July 1, 2023. It is no secret that most of all the Long Island school districts received large sums of monies from state due the recent pandemic, and along with their accumulation of 'Vast Reserves Funds", homeowners will still feel the tax burden come into their households. One particular school district in our local area, North Shore School District has 3.69% tax levy for their proposed budget for the 2023-2024 year. As many school districts try to keep a 2% levy limit, the North Shore School District tends to surpass every school district on Long Island with that type of increase. Their Tax Levy for the 2022-2023 year amounted to \$85,925,546, now to a whopping \$89,092,028. As enrollment at the North Shore School District has decreased the last past two years, our taxes have increased. As a result, the North Shore School District cost of per pupil is now one of the highest in our country which is \$50,000 dollars a year for each student. Therefore, if your student attends this school from K through grade 12 in High School, the cost of education will amount to

approximately \$650,000 from start to finish at this school district.

In conclusion, North Shore School District must try to deliver a better "cost-effective" education product to our residents, and recalculate their proposed budget for the 2023-2024 school year to a 2% levy limit or less for our local residents, anything less will be unacceptable!

I must, in all humility, tip my hat to President Joe Biden and the Democratic Party for pulling off the swindle of the century regarding our open border.

If you had asked me two years ago if Biden and his party could survive after intentionally opening our border to 5 million illegal aliens, I would have pointed you to a psychiatric facility. The public would rebel - or so I thought.

Democrats have been losing the white vote for quite some time now. Republican policies on crime, inflation, and the economy are favored by a majority of Americans polled.

For Democrats to succeed, they must maintain a strong coalition of young and minority voters. The African-American population has been a near monolithic vote for Democrats, usually exceeding a rate of 90%. And despite small recent GOP gains of the Hispanic vote, Democrats still garner at least 60% of this demographic.

Importing several million additional Democratic voters will continue the trend of shading swing states such as Georgia, Arizona and Nevada more purple and blue.

Democrats have gotten away with this despite the enormous cost imposed upon taxpayers, in large part because they've been provided cover by their allies in the mainstream media. Governor Kathy Hochul's plan to force-build 800,000 units of high-density mostly low-income housing in New York was withdrawn - but only for this year. Hochul announced that a budget agreement was reached with the Legislature that dropped her housing proposal.

In what is being called "a victory for the New York Suburbs," Hochul's controversial plan to build 800,000 units of "affordable" housing was not included in the Budget Agreement.

The Hochul plan would have mandated the construction of 800,000 units of high-density housing - sufficient to

house 3.2 million people - by mandating zoning changes to override local towns and villages zoning codes, and suspending environmental laws to override the state Department of Environmental Protection (DEP) regulations.



were put on the endangered species list. "It's tragic and so mind blowing that it could have been fixed if we stopped using pesticides and herbicides and planted local flowers, including the milk weed plants they need to breed."

She just returned from an ecological tour to see the Great Monarch Migration in Mexico in person. "The trips are held twice a year, generally in October and November when the Monarch's head south; and in January and February when they head north. I saw them leaving Mexico. It was an amazing image, especially considering how many thousands of miles they have to fly in each direction. There used to be millions of them, 20 to 30 years ago, but the numbers are declining."





1. To present to the voters a detailed statement (proposed budget) of the amount of money which will be required for the 2023-2024 fiscal year.

2. To discuss all the items hereinafter set forth to be voted upon by voting machines at the Budget Vote and Election to be held on Tuesday, May 16, 2023.

3. To transact such other business as may properly come before the meeting pursuant to Education Law of the State of New York and acts amendatory thereto.

AND FURTHER NOTICE IS HEREBY GIVEN that said Budget Vote and Election will be held on Tuesday, May 16, 2023, between the hours of 6:00 a.m. and 9:00 p.m. in the three (3) Election Districts, described below, at which time the polls will be open to vote by voting machine upon the following items:

1. To adopt the annual budget of the School District for the fiscal year 2023-2024 and to authorize the requisite portion thereof to be raised by taxation on the taxable property of the District.

2. To approve the following resolution for the establishment of a Capital Reserve Fund to finance capital improvements, and related site work and equipment at all district schools:

RESOLVED: That the following action shall result in no additional increase to the annual tax levy. Shall the Board of Education be authorized, pursuant to Education Law §3651, to establish a Capital Reserve Fund to be known as the 2023 Capital Reserve Fund (Reserve Fund). The purpose of this Reserve Fund is to accumulate monies to finance the cost of capital improvements, necessary site work and related items of equipment throughout the district including, but not limited to, the construction and/or replacement of Districtwide facilities and property, capital improvements related to future enrollment growth needs, other infrastructure improvements, window wall replacements, heating and ventilation system upgrades, roof replacement, security enhancements, parking lot and driveway improvements, septic system improvements, instructional space reconstruction, electrical improvements, bathroom upgrades, and interior and exterior doors. The ultimate amount of the Reserve Fund shall be the maximum estimated amount of \$5,000,000.00. The probable term of the Reserve Fund is five years. The source of the funds to fund the Reserve Fund is an annual transfer of surplus money, if any, from the District's General Fund's unassigned balance as may be available at the end of each fiscal year from June 30, 2023 through and including June 30, 2028, and any other sources permitted by law. Except as otherwise provided by §3635 of the Education Law, expenditures from this Reserve Fund shall be made only for the purpose for which the Reserve Fund is established. Locust Valley Library Service Area Residents Only: To adopt the resolution for the Locust Valley Library appropriation submitted for the fiscal year 2023-2024, in the amount of \$1,607,191 to appear on the voting machines on May 16, 2023, and that the Board of Education of the Locust Valley Central School District be authorized to levy the necessary tax therefore on the taxable property only of former Union Free School District No. 4, Town of Oyster Bay, New York.

4. To elect four (4) members of the Board of Education for the following terms:
