

Santos Expelled from Congress

Indicted fraudster George Santos was expelled from the US Congress last Friday after a scathing Report from the US House Ethics Committee detailed dozens of frauds and crimes committed by Santos – and listed many more that the Committee could not investigate because they were part of the FBI’s ongoing criminal investigations.

The Chairman of the Ethics Committee, Congressman Michael Guest (R-MI) personally filed the Motion to Expel Santos.

The House voted 311 to 114 – to overwhelmingly carry the motion. A vote to expel a member takes a 2/3 vote of that chamber, according to the US Constitution.

Republicans were split nearly in half as 105 members voted Yes in favor of expulsion and 112 voted No. Two Democrats voted “No,” and two more abstained from voting.

Santos had evaded previous ouster attempts. However, in November, the Ethics panel released its very damaging Report. The Ethics Committee uncovered additional unlawful conduct by Santos – beyond the 23 count criminal indictment already filed against him – and referred these additional criminal charges to the US Department of Justice.

We can expect another superseding indictment for possibly additional criminal charges to flow from the Ethics Committee’s referral.

The Ethics Committee stated that


Santos’s conduct “sought to fraudulently exploit every aspect of his House candidacy for his own personal financial profit.”

Santos lashed out in anger, demanding that the Ethics committee “Look at members showing up drunk or hungover at votes instead,” and bragged that “I will wear this expulsion as a badge of honor.”

Santos is only the sixth person in US history to be expelled from the US House of Representatives. The most recent was Rep. James Traficant (D-OH) in 2002, after being convicted of multiple criminal felonies. Before that it was Rep. Michael Myers (D-PA) in 1980 after being convicted of bribery.

The other three others expelled were during the US Civil War - all expelled on the charge of “Disloyalty to the Union” after they joined the government of the Confederacy.

One Democrat who opposed Santos’ expulsion was Sen. John Fetterman (D-PA) who said “We have a colleague in the Senate that actual did much more sinister and serious kind of things, Senator Bob Menendez (D-NJ). He needs to go! Um, if you need to expel Santos, how can you allow somebody like Menendez to remain in the Senate.”

But Menendez is a Democrat - in a US Senate with a one-vote Democratic majority. Don’t expect any moves from the Democrats to expel Menendez.

Some Republicans argued that Santos should not have been expelled. NewsMax contributor Krysia Lenzo stated “What Santos did – his lying was despicable and wrong, but they pale in comparison to that of Rep Jamaal Bowman” in regards to his pulling a fire alarm to stop a vote in Congress.

During the expulsion debate, Rep Dan Crenshaw (R-TX) pointed out that when the House Ethics committee panel ran their investigation, Mr. Santos had an opportunity to raise objections and enter evidence in his defense - but choose not to.

All the Long Island downstate Republicans voted “Yes” to expel Santos: Nick LaLota (NY-1); Andrew Garbarino (NY-2); Anthony D’Esposito (NY-4); Nicole Malliotakis (NY-11); and Michael Lawler (NY-17).

In September and October 2022, the North Shore Leader told the truth about George Santos, about him being a “Fabulist” – a fraud and a criminal. The only news publication to do so before the election. This sordid story has now ended with Santos criminally indicted, and expelled from the US House of Representatives. We stand vindicated.

Oyster Bay Man Arrested in Chinatown Stabbing Death

A 19-year-old Oyster Bay man has been arrested in the stabbing death of a teenager outside an “axe-throwing” bar in New York City’s Chinatown.

Arrested is Gianluca Bordone, age 19, who faces manslaughter and assault charges.

Bordone was caught on security cameras stabbing the 17-year-old victim Rocco Rodden, and also stabbing Rodden’s 19-year-old brother. Both Rodden’s were stabbed in the stomach, and were rushed by ambulance to the hospital. The

younger Rodden died several hours later in the hospital from the stab wounds.

The deadly confrontation occurred at 1:50AM on Thanksgiving morning in front of the “Live Axe” bar at 96 Lafayette Street in Chinatown.

Bordone immediately fled the scene in a taxi after the stabbing, together with four friends. He was later arrested about a mile away from the scene of the crime, with blood still on his clothing.

Police charged Bordone with Manslaughter and assault, and the Court has ordered him held in jail on \$4 million bail.

Huntington Roofer Fined \$500K in Worker Death in Glen Cove

An OSHA investigation into the death of an employee found that Elite Roofing Services Inc could have prevented the worker’s fall to his death at a Glen Cove worksite last April.

The dead worker, Noe Diaz-Gamez, 26, of Huntington Station, died after falling 30 feet onto a concrete floor, while repairing the roof of a warehouse at 40 Garvies Point Road in Glen Cove.

The roofing contractor could have prevented falls, according to OSHA, if the company provided legally mandated equipment and training for employees.

The OSHA investigation determined the dead worker, and other employees of Elite, were installing metal decking on a flat industrial roof at Garvies Point Road when the worker fell through an opening onto a concrete floor nearly 30 feet below.

The agency issued six willful violation findings for the hazards – one violation for each exposed worker – and one serious violation for not training the workers. OSHA has assessed \$522,527 in fines for the safety violations.

OSHA’s investigators said they learned the company did not provide the employees on the roof with basic protections such as guardrails, safety nets, personal fall arrest systems, positioning devices or fall restraint systems. The work being completed fell under OSHA’s steel erection standard, and Elite failed to train employees on recognizing and mitigating fall hazards before conducting their steel erection work.

“Despite knowing the risks from falls and the responsibility to safeguard its employees against them, Elite... chose to disregard the law and the safety of its workers,” said OSHA Area Director Kevin Sullivan in Westbury. “Supplying and requiring the use of fall protection equipment and training workers properly on its use can help prevent devastating consequences such as this from recurring.”

Elite has 15 business days from receipt of its citations and penalties to comply, request an informal conference with OSHA’s area director or contest the findings before the independent Occupational Safety and Health Review Commission.

THE FRAUD AROUND "MORE AFFORDABLE HOUSING"

You hear it from every direction - the business groups, the Long Island Builders, and even Long Island's liberal daily newspaper - almost a religious chant that "We must have more affordable housing." But is that possible - or just a self-enriching nonsense?

Housing is what economists call a "supply inflexible" commodity. Long Island already has 1.2 million housing units, for 3.2 million residents. In a New York metropolitan area of over 18 million people.

Yes, housing is expensive on Long Island. Why? Because people earning good incomes - from the entire metro area - want to live here. And are willing to pay for it.

They want Long Island's safe neighborhoods, good schools, green trees, parks, walkable downtowns, easy parking, woodlands, and swimming pools. They want a backyard for family gatherings, their kids to play in, and summer BBQ's. They want to get their families "out" of the violent street crime, rampant drug abuse, and bad schools of NYC.

High demand means higher prices - that is basic Economics 101. And because Long Island is now "fully developed" there is no more room for the kind of "Levittown" mass housing developments that could change the housing market. The Hempstead Plains have been built over.

If builders added 10,000 housing units - a huge number - and all apartments of course due to limited space - then that would add less than 1% to Long Island's housing stock. Meaningless in reducing the cost of housing. But it would add over 25,000 more cars to the roads. And more pollution and garbage and sewage. All bad for the environment.

But it would give the builders and developers over \$10 billion in gross revenues. Yes, \$10 billion. Serious money - but it wouldn't lower rents by even one penny.

The most expensive city in the world is in Africa - the city of Luanda in Angola. Oil money has made many millionaires, but left millions of others with nothing - open sewers, disease, hunger and malnutrition. A decent house in a walled compound in Luanda (and you need the walls) costs \$3 million. A cup of coffee is \$15. And dinner at a decent restaurant is \$750.

Long Island was developed as a middle class enclave. Based on the human ideal of the family cottage or country home. Single family homes, tidy yards and gardens, good transportation, and nice communities.

The Developers' Lobby and the Mass Housing advocates would destroy all that: Crowding and jamming more of the New York metropolitan area's 18 million people - or maybe some of the 10 million new Migrants to America - onto Long Island. To get at that \$10 billion in construction and development cash.

Let's not let that happen.

Finance Op-Ed: Claim the "Bad Business Debt Deduction" for 2023 Tax Return

If your business having trouble collecting payments from clients, you might be able to claim a bad debt deduction on your tax return. But you must be able to show that you've made a "reasonable" effort to collect the debt.

Requirements:

First, a cash-basis taxpayer may claim a business bad debt deduction only if the amount that's owed was previously included in gross income.

Second, a business must establish that the debt is legitimate and can't be recovered from the debtor. To this end, as mentioned, you must make a reasonable effort to collect the amount that's due.

This doesn't necessarily mean you have to file a lawsuit against the debtor. But you can't just make a single phone call either.

Give it your best shot. You might actually be able to collect the debt! But if you can't, you'll have put yourself in a position to potentially claim a bad debt deduction.

Partially or Totally Worthless

Often, the specific charge-off method (also called the direct write-off method) is used for writing off bad debts. In this case, you can deduct business bad debts that became either partially or totally worthless during the year.

For tax purposes, partially and totally worthless are defined as follows:

Partially worthless. The deduction is limited to the amount charged off on your books. You don't have to charge off and deduct your partially worthless debts annually, so you can postpone this to a

later year. However, you can't deduct any part of a debt after the year it becomes totally worthless.

Totally worthless. If a debt becomes totally worthless in the current tax year, you can deduct the entire amount (less any amount deducted in an earlier tax year when the debt was partially worthless).

Note that you don't have to make an actual charge-off on your books to claim a bad

debt deduction for a totally worthless debt. But if you don't record a charge-off and the IRS later rules the debt is only partially worthless, you won't be allowed a deduction for the debt in that tax year. Reason: A deduction of a partially worthless bad debt is limited to the amount actually charged off.

Time Is Short

If you haven't started your collection efforts yet but hope to claim a business bad debt deduction for 2023, time is short. So, spring into action now. For instance, you might start collection efforts through phone and email contacts. If that doesn't work, you may want to follow up with a series of letters or even hire a collection agency. Finally, if all else fails, contact the office about the prospects of claiming a business bad debt deduction on your 2023 returns.

The Polish National Home of Glen Cove, celebrated its 100th anniversary at an event held on its premises on November 11. Dancers in colorful traditional costume, joined by attendees in less colorful but formal attire, performed traditional Polish folk dances.

The celebration took place in the home's Main Floor room, which boasts a fully furnished kitchen and an outward-facing bar, as well as a stage. Polish food and drink accompanied the fun and laughter as attendees gave thanks for an organization and home that has served the needs of the local Polish community of Glen Cove and vicinity since 1922, when a group of local Poles raised the necessary \$6,000 needed to purchase the former St. Patrick's Church at 10 Hendrick Avenue. The original 25 founders at first only managed to raise \$615 before they came up with the idea to sell 50 bricks printed with donors' names at \$100 each – a sizable sum back then.

The home, over the years, has served as a haven for those escaping both war and then communism in their homeland, helping immigrants become United States citizens, and to assimilate in a new country.

Working with the Paderewski Polish School in Glen Head, Polish language classes are offered, to assist Polish Americans nurture their roots and to help those simply interested in Poland and the Polish language.

Other activities include workshops on the practicalities of life, including buying and managing healthcare insurance.

Membership is open to those that have at least one parent or grandparent who is Polish. The home, possessing three different venues, is a popular place to host events, including weddings, christenings and birthdays.

We Must Unite to Stop Hatred and Antisemitism - Right Here

The situation in the Middle East has always been a powder keg and there's a lot to unpack there. Not only has it challenged the best minds since 1948, it has divided the region for thousands of years. The wounds are deep and old, so I won't try to dissect these ancient disputes via the local paper in 800 words or less. It can't be done and that's just the plain truth.

However, I would like to tackle what's happened in New York since the October 7th Hamas terrorist attacks on Israel. Like you, I watched the videos from victims and astonishingly, even from the body cams of the attackers.

What I saw were carefree young people at a music festival and looks of confusion as they incredulously watched the sky. I saw them being chased across fields and savagely gunned down. I watched civilians being attacked, taken hostage, and subsequently heard of victims being tortured and murdered in gruesome fashion, including women and children. Some, American citizens among them, were paraded through the streets in complete defiance of Geneva Conventions with a barbarity that hasn't been seen in decades. That's what I saw, and I can't unsee it.

And while the Hamas celebration videos were distressing, nothing prepared me for Americans here at home cheering them on. But hate spreads faster than you think. Even just a little ember burns hot and spreads quickly when given enough oxygen. Sadly, it seems that oxygen is being provided on the campuses of American universities and high schools.

Almost daily, pro-Hamas rallies turn into violent, ugly calls for the death of Jews and the destruction of Israel. Now we're left with kids removing the Star of David from their necks and skipping classes for fear of being attacked, right here in New York.

At Columbia University an Israeli student was assaulted after he confronted a woman for tearing down posters of Israeli hostages. At an anti-Israel protest at Binghamton University they announced that "Israel is worse than Nazi Germany." At the Cooper Union, Jewish students, fearing for their safety during an anti-Israel rally, barricaded themselves in the library. And things are so bad at New York University that Jewish students, faculty and alumni wrote a letter condemning the administration. It seems that in the name of progressivism, our system somehow

fostered a new kind of intolerance movement, where anything but progress is being made. And lest there be any doubt, this hatred is not directed at Israel, but at Jews, right here in our communities, students in our schools.

Sadly, despite vibrant Jewish communities that have long been part of the Long Island fabric, our schools are not immune either. The antisemitic graffiti has already

started. The taunting text messages, and even slurs at sporting events. In Newsday, our educators said that a polarized society and social media are "a recipe for disaster" because "young people are still figuring out who they are."

As a dad to four young daughters who love concerts, I cannot imagine the pain experienced by parents watching those videos. Nor

can I conceive of being so worried that I advise my child to skip class or hide their identity.

Admittedly, I hope I never do know what that's like and I'm ashamed that friends and neighbors feel this terrorized in their own neighborhoods. We're better than this. And maybe that's the point. Maybe one has to have lived a little and suffered a little to see the futility of hate. Maybe it takes some experience and some age to let empathy guide us instead of a "cause."

Most of us are good people. No matter where we come from, what faith or background – we work hard, we take care of our families, and we live and let live. But sometimes good people have to speak up. And now is that time. It took less than 30 days for antisemitism to take hold in the United States, the same nation that sent our sons to fight Hitler 82 years ago. We cannot afford silence.

In New York, we are asking Governor Hochul to join us in legislation that combats antisemitism in our schools, but I know there is no way to legislate the hate out of people's hearts. It must be challenged every day, fought every single day, by people like you and me.


Please don't give those embers of hatred any room to breathe and grow, not even an inch. Lock arms with your neighbors, whomever they may be, and fight it because it's going to take every one of us to set this right.



Fire Damages Tesla's Lab

A terrible fire broke out at the Tesla Science Center at Wardencllyffe Laboratory in Shoreham on November 21. Over one hundred firefighters from eleven different fire departments responded and finally extinguished the

blaze. Executive Director Marc Alessi said, "To these heroes, we owe a debt of gratitude beyond words." He stated that the full extent of the damage is not yet determined, however the structural integrity of the building, which dates to 1901, seems to have survived. The dam-

age will be assessed by the site engineer, historical architect, structural engineer and the Suffolk County Police Department, the Brookhaven Town Fire Marshall and the County Department of Fire Rescue and Emergency Services. It has been reported that one firefighter was hospitalized.

The brick building, designed by Stanford White, has sustained an estimated \$3,000,000 worth of damage. An emergency fund is in place to repair and

restore the damage to the roof and cupola, which had just been rebuilt in 2019. The fire also damaged the windows, the steel girders, and the bricks.
