Brooke Lupinacci officially kicked-off her campaign for Huntington Town Board this week with a springtime gathering with over 150 people at the Paramount theater in downtown Huntington.

Lupinacci is a former assistant District Attorney and Huntington native, who currently serves as the Labor Commissioner of the Town of Huntington. Her background in crime fighting and administration – and her deep roots in the community – make her uniquely capable to serve on the Town Board.

“I will work to deliver the highest quality of services for residents, protect our suburban quality of life, and safeguard our waterways and environment,” stated Lupinacci.

There are two open seats on the Town Board being selected this year. Incumbent Board members Eugene Cook (R) and Joan Cergol (D) both

chose to retire this year rather than try to seek re-election.

“I have dedicated my life to protecting our community,” stated Lupinacci. “Now I am running for Town Board to protect our quality of life.”

Lupinacci is the Republican nominee, and was joined at the Paramount by her running mate, Theresa Mari, an attorney with her own law firm. They are opposed by Democrats Don MacKay and Jan Herman.

Also running this year are Town Clerk Andrew Raia, a Republican, who is running for re-election; and the Town Receiver of Taxes Jillian Guthman, a Democrat, who is being opposed by Republican Pam Valastegui.

Huntington Massage Parlor Busted for Prostitution

The “Sunny Spa” in Huntington has been busted as a front for prostitution.

Two women have been arrested by Suffolk County police over allegations of prostitution: 39 year old Jing Qiao, a Flushing resident, and 43 year old Xuan Yang, a resident of Roslyn Heights.

Both are in custody after being charged with prostitution. They were also charged with the unauthorized usage of their massage parlor, Sunny Spa, at 825 E. Jericho Turnpike for illegal purposes.

The arrest happened after the massage

parlor was raided by police at around 3:30 PM on April 7th.

In addition to prostitution, the two women were also charged with Unauthorized Practice of a Profession.

Police responded after a number of Huntington residents called, complaining about the “suspicious activity” occurring at the location, and the late hours that patrons would frequent the premises.

An investigation is currently ongoing.

Qian and Yang were arraigned at the First District Court, and both pled “not guilty.”

Robert Spina Wins Fourth Term as Brookville Trustee

Trustee Robert Spina of the Village of Brookville has won a fourth term on the Village Board in an uncontested election.

“Bob has been a tremendous asset to our Village,” stated Brookville Mayor Dan Serota. “Even though he ran uncontested, his years of work on behalf of our Village have made him an outstanding asset.”

Spina moved to Brookville in 1991, where he volunteered for the planning board. He works as a Financial Advisor, based out of Jericho.

Former Brookville Mayor Dick Goodwin appointed Spina to the Zoning Board. After 20 years, he was named to the position of Village Trustee, filling the term of Trustee Scott Roth who had moved from the Village.

Spina also serves as the Director of Emergency Management for Brookville, a job he has embraced with energy and

enthusiasm, and where has been instrumental in putting in place a high-tech communications system in the Village for the Police Department and Road Crew. This has given Brookville quicker and more effective response times to emergencies.

Spina has been a strong force behind the “Code Red” system, that allows the Village to communicate directly (via home phone, cell phone, e-mail and text) with residents, in times of weather or other emergencies.

He also devotes much of his time to community organizations, including raising funds to help rebuild St. Edward the Confessor Roman Catholic church in

Syosset, after a devastating fire.

Spina served five years with the U.S. Army Reserve National Guard and seven years with the U.S. Coast Guard Auxiliary.

Santos, Lafazan Trade “Tweet-War” Personal Insults

Nassau Legislator Joshua Lafazan (D-Syosset) and Congressman George Santos (R-Queens) have launched a mutual “twitter-war,” trading increasingly nasty and personal insults.

Lafazan opened the tweet-war with a fund raising solicitation “Donate to my campaign to get this serial liar George Santos out of the house...”

Santos tweeted-back “real like your chin...” referencing the cosmetic plastic surgery Lafazan had in 2021 when he had chin implants done to give him more of a “Dudley Do-Right” prominent chin.

“Jaw surgery...saved my life,” tweeted Lafazan, adding “I can’t wait to replace you in Congress in 2024...Please send post-cards from jail...”

Lafazan was referencing the multiple criminal investigations over the fraudster Santos. The FBI is investigating Santos theft of \$3,500 from a disabled US Navy veteran; a credit card fraud ring Santos’ ran out of his Florida apartment, according to charges filed by his ex-roommate, a Brazilian criminal names Gustavo Trelha, and numerous fraudulent misrepresentations made by Santos on his per-

sonal and campaign financial disclosures.

But then Santos brought up Lafazan’s own involvement with criminals.

“Coming from the guy that swindled young women for political contributions and was bought and paid for by stolen money from investors SBF defrauded...” reply-tweeted Santos.

Lafazan took \$700,000 in stolen money from criminal crypto-fraudster Samuel Bankman-Fried.

Lafazan is also being investigated over money-laundering “straw donor” allegations when he took \$100,000 from a Centre Island financier, and then made a \$160,000 “personal loan” to his failed 2022 campaign for Congress. He is also reputed to befriend much younger women and young men, to grift money from their families.

“These two fraudsters belong in handcuffs,” noted one leading north shore political operative. “It’s hard to find two more unappealing and dishonest public figures on Long Island. They are both a disgrace.”

Glen Cove Offering Housing Vouchers to Landlords

Property owners in Glen Cove are being requested by the Glen Cove Housing Choice Voucher Program (GC-HCVP) to contact the city, if they would like to be placed on a list of referrals for landlords or they have current vacancies.

Glen Cove hosts many participants who have qualified for the GC-HCVP vouchers and are in the program. These participants are seeking housing for immediate occupancy.

Essentially, the GC-HCVP is a subsidy program for rent. It also is a HUD-guaranteed payment to the landlord. However, it is also subjects participants to obtaining annual recertification and undergoing housing inspection, which would be performed by Glen Cove officials.

Additionally, the HUD 10 percent exception has been implemented by the 2023 Fair Market Rents. This is a result of the higher area market rents.

The program offers vouchers for a studio for \$1,689, a one-bedroom for \$2,105, a two-bedroom for \$2,526, a three-bedroom for \$3,247, and a four-bedroom for \$3,569.

The ceremony was held in Mineola at the Irish Memorial in front of the County courthouse.

On Easter Monday, 1916, the Irish Republican Brotherhood declared the Proclamation of the Irish Republic – declaring the independence of Ireland

from Great Britain, and waged a battle in Dublin and across Ireland against the occupying British army.

The British crushed the April, 1916 uprising, but their brutality launched a broader war for Irish independence.

In January, 1919, the Dail – the elected Irish Parliament - issued a formal Declaration of Independence. And after 2 ½ more years of brutal war, the Irish and British governments agreed in December, 1921, to the independence of the southern 26 counties (out of 32) of Ireland.

Crippen House Salvage Making Progress

The 1653 Foundation - a not-for-profit foundation established to restore, maintain and enhance Huntington's parklands and public spaces, recently presented a check for \$32,000 towards the preservation of the original timbers of the Crippen House.

Although it is in a serious state of disrepair, the Peter Crippen House on Creek Road in Halesite has a tremendous amount to tell us about Huntington's history. Not only is the house perhaps one of the oldest surviving industrial buildings in the country, it was the home of an early African American community leader and his family, for nearly 140 years.

The house is believed to be the first mill building in Huntington, built in 1657 and decommissioned in 1672. It was then moved from Mill Lane to its present loca-

tion where it was converted to a residence.

It was later purchased by Peter Crippen, who came to Huntington from Virginia in the 1830s. Crippen was one of the founders of Bethel AME Church, the first African American church in Huntington. His family continued to own the property until 2019. Occupied for four centuries, the property contains a multitude of clues to Huntington's past.

Plans are being developed to move the oldest section of the house to the property at the southwest corner of New York Avenue

and Mill Dam Road. There the house will be restored and opened to visitors who will learn more about this chapter of our community's history.

The plan is to save the legacy timbers (circa 1658) and to utilize these relics as one of the catalysts for the creation of the Huntington African American Museum.

Dredging Threatens Shellfish Population in Oyster Bay

The New York State Department of Environmental Conservation (DEC) issued a permit last week to Frank M. Flower & Sons to transplant shellfish from uncertified waters in Mill Neck Creek to certified waters in Oyster Bay for eventual harvesting.

Last year's initial permit given to the company allowed the operation to go on for three months, but the new permit is in effect for six months - until October 10th. Now, two Flower vessels are already dredging in Mill Neck Creek.

The idea for the project was first advanced three years ago, but was canceled when the Town of Oyster Bay, worried about the protection of resources within the Lester Wolff National Wildlife Refuge, decided not to monitor the operation. The DEC allowed the project to proceed by agreeing to do the monitoring itself.

The environmental organization Friends of the Bay ("FOB") notes that throughout its decades-long campaign to preserve, protect, and restore the Oyster Bay/ Cold Spring Harbor Estuary, it has supported the operations of Flower to maintain its hatchery and to plant hundreds of millions of seed clams and oysters in the bay.

The continued hatchery and seeding operations guaranteed an abundant standing stock of shellfish, substantial enough to provide benefits essential to any functioning estuary - including water filtration and purification, and a source of food, habitat, and shelter for numerous species.

Each adult oyster or clam filters 25 gallons of water per day.

But after the 2019 season, the company closed its hatchery in Bayville, and stopped planting oyster and clam seedlings to replace what was harvested. The company thus transformed from "shellfish farmers" into "shellfish miners," according to FOB.

"For the last three seasons the company has been dredging to strip the bottom of all marketable shellfish, leaving little

behind," Friends of the Bay says.

Observers note that Flower's terms of the underwater lease and the town code give Flower the right to all shellfish on the leased lands -- but the lease itself is predicated upon the cultivation of shellfish. Since 2019, when it stopped shellfish seeding 2019, Flower has not lived up to that part of the lease, according to FOB.

Flower's current, 6-month operation threatens to leave the shellfish population in the Oyster Bay-Cold Spring Harbor complex dangerously over-harvested, without the number or density to recover.

Similar shellfish population collapses have occurred all over Long Island. Decades later, many bays, including the Great South Bay, are yet to recover.

The Town of Oyster Bay has itself launched an aggressive program of hatching seedlings and seeding the bay. Supervisor Joe Saladino has made preservation of the environment a priority, and built oyster hatcheries on the bay.

The uncertified waters of Mill Neck Creek serve as an undisturbed spawning sanctuary for shellfish - spawning which can help repopulate the bay. Not only does the area have one of the highest shellfish population densities in the estuary, but the strong tidal flow from the creek carries spat well into the bay, helping to sustain shellfish populations well beyond the geographic limits of the Creek.

Dredging would disturb the substrate, with potentially devastating impact on other areas of the bay system.

Grieving With Compassionate Friends

Last year I joined a club that nobody chooses to join, yet it is growing in numbers. Compassionate Friends is the name of an organization comprised of groups of bereaved parents who meet regularly for emotional support. I attended my first meeting three months after the death of my youngest son.

There are over five hundred chapters in all fifty states and in Washington DC, Puerto Rico and Guam, and worldwide. In Nassau County there is a chapter that meets at the Glenwood Landing American Legion, 190 Glen Head Road. In Suffolk County there is a group that meets in Mastic and another that meets via Zoom. The groups are very diverse, and every grieving parent is welcome.

The Compassionate Friends, TCF, was founded in England in 1968 and as a nonprofit organization in 1969, at what was then the Warwickshire Hospital, now the University Hospital, Coventry, when two young boys died within days of each other, and the chaplain brought the two sets of grieving parents together. There are now chapters all over the world.

A mass candle lighting, believed to be the largest in the world, is held on the second Sunday of December each year at 7pm local time creating a virtual twenty-four-hour wave of light as it moves from time zone to time zone, uniting families and friends around the globe

to honor the memories of sons, daughters, brothers, sisters and grandchildren who left too soon.

The death of a child is traumatic, and parents grieve no matter the age of their son or daughter, whether infants or adults forty and older. A parent never recovers from the loss of a child, it's not the natural order of life.

There were also many sorts of deaths, but there is no judgment only understanding. Everybody who attends is in a different phase of their grief journey. Some are new to the group and have just recently experienced the loss, others have attended meetings for years, helping others to cope with their loss. Many of the longtime attendees become the leaders of the groups, who welcome the new people, and read the names of those children whose birthdays are that particular month. There are guidelines to participation. Nobody is obliged to speak, but when it is your turn to speak others must listen. You are asked to speak only of your own experience and not to offer solutions to others. If your faith has been helpful that is fine, but some people have

a difficult time and experience anger at God or their higher power. At meetings it's fine to cry, and it's also fine to laugh. Many people attending say that Compassionate Friends has been a life saver for them. If you, or someone you know, has lost a child, sibling or grandchild, please let them know there is a caring support group available to help guide them through their grief. The mission of TCF is to provide friendship, understanding and hope to those going through the natural grieving process. I know that it has been a great help to me.

There is another group which meets via Zoom based on Long Island but has people joining from all over the country. Whereas TCF welcomes grieving parents whose children died from many different causes, this group is for parents whose children died from drug overdose and was formed in 2016. www.beading-hearts.org. Not bleeding but beading, as they give you beads that say Look up for... (your child's name.)



The ultimate amount of the Reserve Fund shall be the maximum estimated amount of \$5,000,000.00. The probable term of the Reserve Fund is five years. The source of the funds to fund the Reserve Fund is an annual transfer of surplus money, if any, from the District's General Fund's unassigned balance as may be available at the end of each fiscal year from June 30, 2023 through and including June 30, 2028, and any other sources permitted by law. Except as otherwise provided by §3635 of the Education Law, expenditures from this Reserve Fund shall be made only for the purpose for which the Reserve Fund is established. No expenditure shall be made from this Reserve Fund for any other purpose other than the above without such additional actions or proceedings as may be required by law.

3. Locust Valley Library Service Area Residents Only: To adopt the resolution for the Locust Valley Library appropriation submitted for the fiscal year 2023-2024, in the amount of \$1,607,191 to appear on the voting machines on May 16, 2023, and that the Board of Education of the Locust Valley Central School District be authorized to

levy the necessary tax therefore on the taxable property only of former Union Free School District No. 4, Town of Oyster Bay, New York.

4. To elect four (4) members of the Board of Education for the following terms:

a) three (3) members of the Board of Education to three-year terms commencing July 1, 2023 and expiring on June 30, 2026.

b) one (1) member to fill the remainder of an unexpired term commencing May 16, 2023 and ending June 30, 2024.


