#### The Nassau County Museum of Art Has The Blues

The Nassau County Museum of Art was planning a preview of their new exhibit Blue, on March 13, when it was shut down due to the Corona Virus. The exhibit is on until July 5, but in the event that it hasn't opened by then, you can go on a virtual tour on the museum website, led by the Museum Director, Charles Riley.

The color blue is most popular with artists and musicians, poets, designers filmmakers, and many other forms of expression. The Pantone Color Institute chose classic blue as the color of 2020.

This exhibit includes, paintings, photographs, ceramics, fashion, sculpture, and more. In the words of Charles Riley the museum is "a multi-media exploration of blue in many incarnations."

Riley also includes a quote from the artist Miro, who said, "This is the color of my dreams."

The exhibit spans history and geography and includes cabinets filled with semi-precious lapis lazuli, which in ancient times was prized by royal families and mystics. It's now used in Feng Shui as an element of healing. Blue is the color of the sky and the sea, and is known as a sacred or holy color, as in Sacred Blue, or Sacre Bleu in French, is both a color of paint, supposedly named for the cloak of the Virgin Mary, and a curse word derived from Sacre Dieu, Holy God, which is taking God's name in vain, so the color, which rhymed with Dieu, was substituted.

Artists in the exhibit include Picasso, Miro, Roy Lichtenstein and many others.

### Huntington Old Town Hall Hotel a "Go"

The Huntington Town Board has approved the rehabilitation and conversion project for the long-vacant, but historic, Old Town Hall. The building, on Main Street and Stewart Avenue, is to be converted into an 80 room boutique downtown hotel. The hotel will operate under a Hilton-Hampton Inn franchise.

The Town Board voted at its March meeting for development approval. Construction crews have already started clearing the lot and grounds for the much-anticipated project.

The Old Town Hall served as the seat of Huntington's town government from 1910 to 1979, when the current Town Hall complex was built 1/4 mile further east on Main Street. The Old Town Hall building is on the National Register of Historic Places, and anchors the east end of the Huntington village downtown area, right across from the historic Cemetery.

A member of the town's Historic Preservation Commission, Elissa Kyle, praised the plan, stating that "Visitors to the hotel will be more likely to patronize nearby shops and restaurants than if they were staying at a hotel outside of the downtown."

The Old Town Hall property was purchased in 2018 by a group headed by George Tsunis, a Cold Spring Harbor resident. Tsunis is from a prominent local business family, and serves as the chair Chartwell Hotels. Tsunis has also served as Chairman of the Board of the Nassau County Medical Center, and was once a candidate for Suffolk County Legislature.

The development of the Old Town Hall Hotel is expected to have a construction budget of \$24 million, generate at least 100 construction jobs, and to have 15 full time hotel staff. The current building of the Old Town Hall will be converted into a hotel lobby, dining room and gym, and an adjacent 54,000 square foot new building will be constructed along Stewart Avenue, with the 80 rooms on three floors. Construction is expected to begin immediately.

# Huntington Marinas Reopening

"The opening of marinas and boat ramps is good news for boaters," exclaimed Huntington Supervisor Chad Lupinacci, as the Corona shutdown began to ease. Halestite Marina on New York Avenue and Mill Dam Marina on

Mill Dam Road, both in Halesite, are now open and serving the public. The marinas are being provided launch service by the Gold Star Motorized Boat Launch.

Lupinacci asked boaters to continue to exercise social distancing and to "wear a mask when you cannot distance yourself from others." # Newsday Gets \$10 Million in US Govt PPP Funds

Newsday, the liberal daily newspaper based in Melville, has received \$10 million in US government funds making it one of the largest single recipients of government Corona funding on Long Island. The first round of the Payroll Protection Program ("PPP") funding over \$400 billion, has been widely criticized as being steered to the "preferred customers" of the banks administering the program.

In 2008, Cablevision corporation, then owned by Charles Dolan of Oyster Bay, purchased Newsday for \$650 million. In 2015, Dolan sold all of

Cablevision, including Newsday, to the Netherlands-based Altice corporation for \$17 billion. The next year, Altice sold back its ownership interest in Newsday to Dolan, and his son, Patrick Dolan, who is now Newsday's CEO.

Over 90% of small businesses received nothing from the first round of the PPP program, before its funding was consumed in a little over a week. The US government has now passed a second round of PPP funding. According to Newsday, the print newspaper has an average daily circulation of 156,224 papers.

# Oyster Bay Opens Golf Courses

New York State has authorized marinas and boat ramps to reopen. The State has reopened its golf courses, including the courses at Bethpage State Park.

The Town's Golf Course and Driving Range in Woodbury reopened on Friday, April 24th without the use of golf carts. The course is open Tuesdays – Sundays, with the first tee time at 7am and last tee time at 3:56pm.

Twilight golf takes place Tuesdays – Sundays, from 4pm to 5pm. Both golfers and boaters must obey strict social distancing and sanitization protocols. No night fishing is permitted at TOBAY Beach at this time.

#### **Beyond 1984:** The Scientific Illiteracy and Fascism of Cuomo's "Contact Tracing"

Last week Gov Andrew Cuomo announced a new multi-billion dollar plan - started with a \$10 million gift from Mike Bloomberg - to start "contact tracing" New Yorkers. The government will hire 100,000 "trackers" to use home visits, cell phone GPS location data - and tips from anonymous sources - to identify people "suspected" of being exposed to Corona. The Contact Tracers will then have the power to arrest, quarantine, isolate, medically test, and shut down all social interaction with anybody "suspected" of being exposed.

The first problem is that the plan is useless. Corona is hyper-contagious: You can catch it from touching exposed surfaces; others sneezing in the next aisle in the supermarket; bad ventilation ducts, or a thousand other ways. Testing shows that nearly 30% of NYC residents and Long Islanders have already been exposed.

Most people have no idea how they caught it. At a State Prison in Marion, Ohio, where 2,028 out of 2,300 prisoners tested positive last week - and 95% of those showed no symptoms - the Warden had "no idea" how Corona entered and spread through the prison. If "contact tracing" doesn't work in a prison, then how can it work among a dynamic mobile population?

Corona is especially untrackable. It spreads too easily to be tracked, and most infected people show no symptoms.

The other big issue is the huge danger to our freedom. Do we really want to give the government the vast power to "contact track" every interpersonal relationship and interaction using our cell phones and 100,000 new government agents as spies - to see who we are having lunch with, or meeting with, or talking to?

And then lock-up people "suspected" of being exposed - which is already 30% of the population. Isn't this exactly the nightmare that George Orwell wrote about in "1984."

Anyone who cares about our freedom needs to speak and act now to stop "Contact Tracing." It is medically useless, scientifically illiterate, and blatantly fascist.

A couple of weeks ago, with the fear and uncertainty lying before us regarding the COVID-19 pandemic, my husband and I, like many others, were feeling rather down. To combat this, we reinvigorated a program we started before the winter holidays called, "Do Good to Feel Good." And it's worked for us!

There's no better way to lift your spirit than when you do something to help someone else, and the time is NOW when a lot of people have less income, and NOW is when those in medical-related fields are putting their lives on the line for us. In the past month, we've been able to deliver nearly 900 cases of food to Glen Cove and its surrounding community. We've been able to help feed seniors with direct delivery to homes, and lowincome residents through the First Baptist Church's soup kitchen as well as with direct delivery. I had never been involved with the school district food pantry other than with donations in the past, but last week I made a plea online to the Glen Cove Neighbors Facebook page since the pantry was shorthanded that week when Island Harvest couldn't deliver their usual supply. This plea for support received such an outpouring of food and monetary donations that the pantry was able to be re-stocked, and hundreds of pounds of protein, and 100 cases of eggs were able to be purchased. "Do Good to Feel Good" has also been

able to show our appreciation with cases of snacks to Glen Cove Hospital, the Department of Public Works, several police, fire and EMS departments, several pharmacies, urgent care centers, and others.

Our main sponsor is JAG Specialty Foods through my husband, John Ferrante, and his two business partners, former Glen Cove resident Gregg DeSantis and an anonymous current one. 
# NS High School Senior Named 2020 Regeneron ISEF Finalist

Congratulations North Shore High School senior, Mary Sotiryadis, who was named a 2020 Regeneron ISEF Finalist. Mary spent her entire summer in a lab at the Hospital for Special Surgery in New York City working behind a hood to protect the precious cells that she was experimenting on. Each day she checked to make sure they were healthy and regularly provided the cells with all the nutrients they needed to thrive. These cells would be the key to unraveling the role of blood components in patients suffering from chronic inflammation. By the end of the summer, Mary had discovered the major protein responsible for tissue damage during the inflammatory response. Her findings can lead to major drug discoveries for disorders such as

In early April, Mary presented her project virtually in the New York State Science and Engineering (NYSSEF). After making it through the first round, she was invited to compete in a "lightening round" where a panel of professional scientists questioned her on the details of her research project and its implications. Ultimately, her work was named a top project in her category-Biomedical Engineering and Heath Sciences- and has earned her a spot in the International Science and Engineering Fair (ISEF).

Each year Regeneron ISEF hosts approximately 1,800 students that have advanced from their regional fairs in over 75 different countries or territories. Students are awarded nearly \$5 million dollars in prize money to the top 600 teams and individuals, including a top prize of \$75,000. Special awards are also

Dr. Molly Mordechai, North Shore High School Science Research Teacher said, "I am extremely proud of Mary's accomplishment. She is an intelligent and hardworking student who truly deserves this recognition. A copy of the proposed budget shall be made available to residents of the School District beginning on May 26, 2020 on the District's website at www.lvcsd.k12.ny.us. While Education Law Section 1716(2) requires the budget also be made available at school district offices, any public library/free association library within the district and the polling place, this year that will not be possible due to the Executive Order and the prevalence of the COVID-19 virus and potential for spread through personal interaction.

AND FURTHER NOTICE IS HEREBY GIVEN that pursuant to Executive Order 202.26, said Budget Vote and Election of Board of Education members will be held on Tuesday, June 9, 2020. The Executive Order directs that the budget vote and election be conducted by an absentee ballot process in lieu of in-person voting. Locust Valley Library Service Area Residents Only Vote for Proposition Two (2): To adopt the resolution for the Locust Valley Library appropriation submitted for the fiscal year 2020-2021, in the amount of \$1,472,775, to appear on the absentee ballots on June 9, 2020, and that the Board of Education of the Locust Valley Central School District be authorized to levy the necessary tax therefore on the taxable property only of former Union Free School District No. 4, Town of Oyster Bay, New York.

My hope is that when we all eventually get back to work and school and the Club,



She received her Botanical Art and Illustration Certification at the New York Botanical Garden. Nancy was a gifted water colorist in her own right, and well known for her elegant taste and creativity.

Her love of nature stemmed from her

time in Langau, the family's former Austrian hunting estate, where as soon as she could walk, she prowled the forests, mountains and valleys. It was there she shared some of the happiest moments with her family and with great joy also her Austrian friends and those from around the world.

A New York City resident, Nancy was a member of the Colony Club, Piping Rock Club, Bathing Corporation of Southampton and the Meadow Club.

She served on the Women and Foreign Policy Program Advisory Council at the Council on Foreign Relations and co-founded "Women's Partnership for Science" at the Cold Spring Harbor Laboratory.

Nancy will always be remembered as a force of nature. She loved her children deeply. The passionate loyalty she felt for her family and friends was fueled by her generosity, curiosity, and her sparkling enthusiasm that was contagious at social occasions and in private conversations alike. Her humor was infectious, and her laughter could be heard from miles away. She will be deeply missed.

Nancy is survived by her three children, Gwendoline, George and Henry Tilghman; partner Walter Terry; brother Geoffrey Hoguet and sister in law, Annalu Ponti; and the many for whom she was an irreplaceable spirit in their lives.


