

## Smyth: Stop Apartment Over-Development in Huntington

Huntington Supervisor Ed Smyth has proposed changes to the town code to prevent downtown commercial space from being converted into high-density apartments.

The Town Board will hold a public hearing on May 10th, to discuss the

measures to limit the expansion of multistory apartment building development and to mediate its impacts on downtown parking congestion.

The impetus for the rule change came from a pending application by the owners of the former "Ann Taylor Loft" building at 263 Main Street, who are seeking to

turn the second and third floor office space into apartments - but not to build any significant new parking.

They are seeking to supplement the inadequate private parking spaces at the Anne Taylor property by using the municipal lots as parking for approximately 40 of their would-be apartment tenants.

"We want to close this potentially devastating loophole in our Town Code and give applicants the clear guidance that our downtown areas

are open for business, culture, and economic investment, but not the rampant over-development of apartment buildings with no parking," stated Smyth. "Apartment developers can no longer rely on municipal parking lots to satisfy their off-street parking requirements."

In 2020, Smyth - then a town councilman - proposed the law to limit the unregulated expansion of apartment development in areas zoned C-6 in the commercial downtown of Huntington.

His current proposal seeks to further limit the expansion of retail shops into multi-story apartment building development. The measure would also address the impact of this apartment development on parking congestion.

The scheduled public hearing will aim to "clarify the rules regarding parking requirements relative to a proposed conversion of existing multi-story structures within 300 feet of municipal parking lots to residential use on the upper floor(s); to control the unregulated expansion of apartments in Huntington Village," according to the Town's Public Information officer.

## Billy Joel Settles Lawsuit Over Home Renovations

Star recording artist and Centre Island resident Billy Joel has settled a lawsuit with a contractor company that sued Joel after they were fired by him.

The company, Berry Hill
Development Corporation of
Woodbury, owned by Paul
Laruccia, was hired in Sept
2018 to renovate the Piano
Man's home, located on 29
acres of waterfront property in Centre

Island.

The renovation was to cost \$1.9 million but that amount rose to \$7.5 million after additional work was proposed.

Joel and his wife Alexis terminated cooperation with Berry Hill in Nov 2019, after a structural engineer's report indicated structural damage. Berry Hill, which says it had been paid \$2 million for \$2.6 million of work done then sued for the difference, part of the billable amount

of uncompleted work, plus \$16.25 million in unspecified damages, interest and attorney's fees.

Berry Hill alleges that proper procedures were not followed in its termination. They also alleged a "copyright violation," claiming that the next contractor hired - Neil James Stufano of Caine Architecture - submitted 'nearly identical'

architectural plans to the Centre Island building inspectors. Berry Hill claimed that the plans that had cost over \$126,000 to make, and that they held "intellectual property" rights to the plans.

Joel's attorney said that the successor contractor Stufano filed plans that were "much more comprehensive." He also observed that "since we are talking about an existing house, there are certainly a lot of similarities, but such similarities aren't copyrightable."

The newly renovated and expanded LIRR Huntington South Parking Lot was opened Wednesday, April 13th with a ribbon-cutting ceremony.

"We are proud to deliver on this longawaited renovation in the first few months of our administration," stated Huntington Supervisor ed Smyth. "But the best is yet to come!"

The project added 29 new parking spots, bringing the lot to 253 spaces; a new accessible sidewalk on east side of Fairground Avenue; drainage improvements; lighting improvements; resurfacing with new asphalt paving; two-way

traffic flow down each aisle; reconstruction of the southern retaining wall; and the installation of EV conduits for the potential installation of electric vehicle charging stations if funding becomes available to add such infrastructure in the future.

The town was given the go ahead to finish the \$4 million in upgrades to the commuter facility, along with the MTA's Municipal Facilities Program (SAM) Grant funding.

"We anticipate moving forward on more commuter infrastructure upgrades at the Huntington train station with recently approved grant funding," added Smyth. "Thank you to Jim Ahrens and our Engineering team, our Highway Superintendent Andre Sorrentino and his team, the Departments of General Services and Transportation and Traffic Safety for all of their work to complete this project on a shoestring budget."

### **EDITORIAL**

#### STOP APARTMENT OVER-DEVELOPMENT

The over-development of apartment blocks and multi-family housing on the North Shore - often in the least rational locations - has already clogged our roads with too much traffic, and overloaded our infrastructure. It seems like some developers want to turn our neighborhoods into Queens, rather than protect our green, leafy neighborhoods.

There is a time and place for apartments and condominiums: Urban planners always urge that multi-family housing should be located close to transportation hubs and downtown areas. The rationale is clear: people living in highdensity multi-family housing are best served by being able to walk to public transportation - buses and trains - or stores. And multi-family housing developments built away from transportation hubs become clogged with cars, since everyone then needs a car to get anywhere.

Long Island was developed as a suburban preserve of single-family homes. Unfortunately, our local governments have rarely been very good at urban planning, which is why so much of the multifamily construction that does occur, is done in scattered developments. The location of apartments too often reflects not rational urban planning - but the political pull of the developers or their

That is why the proposals by Huntington Supervisor Ed Smyth to limit apartment developments and stop apartment conversions with inadequate parking is a needed and courageous stand. A welcome respite from the rampant building of new apartments.

Smyth's proposal is a result of the attempt by the owners of the Anne Taylor shops, in downtown Huntington, to convert their upstairs office space into rental apartments. Except the building has almost no parking, and all the new tenants would be using the public parking lots. On weekend nights it is already often impossible to find parking. Now add another 50 or 100 cars.

In Huntington, Hicksville, Northport, Glen Cove and Woodbury, thousands of new apartments have been recently built or are being planned. Sometimes - like at the Garvies' Point development in Glen Cove - the new buildings turn a blighted area into a luxury neighborhood.

But too often the new building just enriches the developer, while leaving the existing homeowners to pick up the extra cost of new sewage, schools, roads, and parking. The apartment development behind the Mandarin restaurant on New York Avenue in Huntington is one of the more egregious examples of political favoritism, as the former Petrone administration rushed through the approvals before leaving office four years ago. An ugly apartment block dropped into the middle of shopping center parking lots.

Let us demand better of our political leaders, and support those who are dedicated to keep out communities green, safe and suburban.

## **Op-Ed: Two Hugely Expensive Proposals About To Be Passed**

#### 1. New buildings must be heated with electric heat

The New York State Legislature is about to require that all newly constructed residential and business buildings under seven stories in New York State be heated through massively expensive electric heat. ## **Op-Ed: A Wealth Tax Can't Survive Constitutional Scrutiny**

The Biden administration is looking to impose a new "Wealth Tax" as part its American Families Tax Plan, that seeks to tax unrealized gains and asset appreciation. It's a dangerous proposal - but thankfully it is unconstitutional.

For a Wealth Tax to pass Constitutional muster, it must properly be "apportioned" in accordance with the Sixteenth Amendment, unless it is a clear tax on income. According to the US Constitution, Section 2, Article 1, "direct taxes shall be apportioned among the several States...according to their respective numbers."

The Sixteenth Amendment (income tax amendment) eliminated the apportionment requirement for 'taxes on incomes' and made the modern income tax possible. However, it also left intact apportionment for all other direct taxes – ie all taxes on things other than income.

Despite Biden's wish list, it has long been settled that "unrealized" appreciation is not "income."

According to the US Supreme Court case of Eisner v. Macomber (1920), the increase in the value of an asset or property does not become "income," unless and until the asset or property is sold. "Undistributed accumulated earnings and profits are not income and, therefore could not be taxed to its owners..." said the Supreme Court.

This position is summarized by tax expert and tax partner David Rivikin (a partner at Baker& Hosteler) who stated, "Taxing unrealized capital gains is not taxing income."

lower Court rulings: First, was a chal-

lenge to the Trumpera "Tax Cuts & Jobs 2017" Act of (TCJA), which imposed Mandatory Repatriation Tax taxing US Citizens who have accumulated foreign earnings.

Two tax petitioners, Charles and Kathleen Moore challenged TCIA as a direct tax, in violation of the US Constitution, on their foreign earnings of their stock which they have not repatriated

A Federal District Court ruled against the Moores, on the reasoning that the standard of what is income should be viewed "expansively," citing an earlier case of Murphy v. U.S. (1993), that requires "taxpayers holding certain futures contracts to recognize the gain or loss on those contracts annually, regardless of whether the taxpayer disposed of the contract during the year." The Moore case is currently on appeal in the US Federal Ninth Circuit Court of Appeals.

A more recent case - Commissioner v. Glenshaw Glass - sets forth the three basic elements to what is taxable. That criteria being (1) accessions of wealth (one has greater wealth because of the item), (2) clearly realized gain (meaning one actually receives the increased wealth of that item) and (3) complete dominion (meaning one has control over the item).

The issue of whether a tax is an "income tax" or a "direct tax" has not been The Biden staffers rely upon a two fully resolved by the courts, but the Biden

wealth tax most closely resembles a direct tax - and is not an income tax. It would thus be unconstitutional – unless the new tax were apportioned to the states.

The process of attempting to apportion a tax is a cumbersome and exhausting process, since many states, such as Alabama, Alaska, Delaware, New Hampshire, North Dakota, Vermont and West Virginia do not currently have any billionaires: The majority of billionaires are situated in New York and California. So the tax would have to hit those states much harder.

In conclusion, this issue of taxing unre-

alized gains by the proposed Biden wealth tax would – if it were to pass – have to be extensively litigated in the courts. But given the prior rulings of the Supreme Court, and the plain language of the US Constitution, I wouldn't bet on the constitutionality of any such wealth tax.




